These further works are required to re-build a larger portion of the domed roof to ensure the Council's stock of emergency salt is kept dry.</p> <p>ALTERNATIVES CONSIDERED AND REJECTED</p> <p>There are no other options available, based on technical advice from the Council's Chartered Building Surveyor.</p> <p>FURTHER INFORMATION</p> <p><i>The report relating to this decision can be found here:</i></p>
