DECISION	APPROVED That the Cabinet Member for Property and Infrastructure and the Cabinet Member for Finance agreed to the capital release request of £20k from the Property Works Programme (PWP) Capital Budget 2021/2022; Contingency Fund – Further Works to the timber structure at Manor Farm Great Barn (see Appendix A of the report)
Reason for decision	As part of the previously approved Capital Release and subsequent works, due to additional issues with the timber structure, these works are required to maintain the stability of the structure and treat an area where Death Watch Beetle Larvae have been found.

	These works will help ensure the amenity can be enjoyed by our residents and continue to operate as a wedding venue, a revenue stream for the Council.
