Accept the tender from TRAC Associates Ltd for the provision of Asbestos Management Surveys, Air Sampling and Technical Support across the HRA and Corporate Estate</li><li>2. Agree that this includes the provision to extend the contract for a 2-year period (5 years in total), subject to the extension being agreed under the relevant delegated authority.</li></ol>
