<b>Cabinet Members making the decision</b>	Councillor Jonathan Bianco – Cabinet Member for Property and Infrastructure  <b>Approved</b>  <b>That the Cabinet Member for Property and Infrastructure agreed the terms for the renewal of a lease negotiated by officers as detailed in the report and authorised Legal Services to complete the new lease on these terms.</b>
<b>Reason for decision</b>	The Cabinet Member agreed the proposed lease renewal in accordance with the Council's Constitution. This requires the Cabinet Member for Property and Infrastructure to formally authorise the grant of a lease of 7 years or under at a rent of between £10k - £100k.
