	<b>Approved</b>  That the Cabinet Member for Finance and the Cabinet Member for Property and Infrastructure approved the capital release request of £62k from the Structural Work-Stream within the Housing Revenue Account Works to Stock Programme 2021/22 capital budget for the structural remedial works to the Divisionary Wall at the rear carpark area behind 13 to 16 Burness Close.
Reason for decision	Progressing the works will stabilize the divisionary wall so the supporting scaffolding can be removed making them safe for many years to come and will ensure that the Council is carrying out its obligation to maintain its built assets.
Alternative options considered and rejected	There are no alternatives, if works are not undertaken the costs will increase in time and more works will be required in the long term.
