	<b>Approved</b>  <ol style="list-style-type: none"><li>1) That the Cabinet Member for Finance agreed to the request from NHS Property Services to allocate a total of £12,162 from an s106 contribution held at H/55/347D towards the provision of a new health centre on the former Cottage Hospital Site, Pinner Road, Northwood and</li><li>2) That the Cabinet Member for Finance and Cabinet Member for Health and Social Care approved the capital release (Appendix A) and transfer of the S106 funds held at H/55/347D to NHS Property Services, to be spent within the terms of the Service Level Agreement (SLA) dated 26 June 2015.</li></ol>
<b>Reason for decision</b>	In accordance with the Council Constitution, the allocation of Section 106 (S106) and Section 278 (S278) funds are required to be formally approved by the Cabinet Member for Finance on a case-by-case basis – and any capital release in conjunction with the relevant Cabinet portfolio holder. This decision approves that the S106 funds held at the case reference detailed in the report to be committed as outlined in the report
