<b>Cabinet Members making the decision</b>	The Leader of the Council, and on behalf of the Cabinet Member for Finance and the Cabinet Member for Children, Families and Education
	<b>APPROVED</b>  <b>That the Leader of the Council, and on behalf of the Cabinet Member for Finance and the Cabinet Member for Children, Families and Education:</b>  <b>1) Noted the cost increase to the Wood End SEND project by £474k from £1,337k to £1,811k; and,</b>  <b>2) Approved the capital release request of £1,695k from the 2023/24 Schools SRP/SEND capital programme budget.</b>
<b>Reason for decision</b>	The Local Authority's approval of the increased project cost will trigger the appointment of the preferred contractor to carry out building works. Approval of capital release will ensure the continuation of the work to create a new ASD unit for 24 pupils at Wood End Park Academy. This capital release requested the release of funds for the pre-construction and construction phase of the scheme.

<b>Alternative options considered and rejected</b>	The Local Authority agreed to provide funding for a scheme to create a 24 place ASD unit at Wood End Park Academy and the delivery of project will be managed by The Park Federation Academy Trust. The project is linked to the DSG Safety Valve Programme.
