<b>Decision</b>	<b>Approved</b>  <b>That the Cabinet Member:</b>  1) Considered the objections received from the statutory consultation for the proposed limited waiting restrictions on Botwell Common Road, Hayes;  2) Did not approve the introduction of the proposed limited waiting restrictions on Botwell Common Road, as shown on Appendix B; and  3) Approved an amended proposal for limited waiting restrictions on Botwell Common Road, as shown on Appendix C to this report, and to keep the matter under review.
<b>Reason for decision</b>	To improve access on Botwell Common Road, yet still maintaining parking for residents.
