<b>Cabinet Members making the decision</b>	Councillor Jonathan Bianco – Cabinet Member for Property, Highways and Transport
<b>Decision</b>	<b>Approved</b>  That the Cabinet Member for Property, Highways & Transport: <ol style="list-style-type: none"><li>1. Noted the application for a disabled parking bay in Radnor Grove, Hillingdon;</li><li>2. Considered the objection to the proposed disabled persons' parking bay on Radnor Grove, Hillingdon; and,</li><li>3. Did not approve the installation of the proposed disabled persons' parking bay on Radnor Grove, Hillingdon, as shown in Appendix B to this report.</li><li>4. Approved the retention of the existing bay opposite No 9 Radnor Grove for this applicant's use.</li></ol>
