<b>Cabinet Members making the decision</b>	Councillor Susan O'Brien – Cabinet Member for Children, Families and Education
<b>Decision</b>	<b>Approved</b>  <b>That the Cabinet Member for Children, Families &amp; Education has not agreed the request by Bishop Winnington Ingram to meet the full or partial cost of redundancies associated with the proposed changes to its non-teaching staff structures.</b>
<b>Reason for decision</b>	The school did not take sufficient action until 2021, therefore, the staffing reductions and subsequent redundancy costs arise from a deficit partly caused by factors within the school's control.
<b>Alternative options considered and rejected</b>	To have agreed to meet the full or partial redundancy costs. This has not been recommended for the reasons set out above.
