<b>Decision</b>	<b>Approved</b>  That the Cabinet Member:  <ol style="list-style-type: none"><li>1. Noted the responses to the informal consultation on a possible residents' permit parking scheme in roads bounded by Providence Road and Whitethorn Avenue, West Drayton;</li><li>2. Based on the responses received during the consultation from residents, agreed that a formal consultation is carried out in Edgar Road, and that the scheme is implemented if supported during that consultation; and</li><li>3. Noted the views of the other roads informally consulted and defers any further action to progress a scheme at the present time.</li></ol>
