<b>Decision</b>	<b>Approved</b> That the Cabinet Member for Finance and the Cabinet Member for Property, Highways & Transport agree to the capital release request of £300k from the Highways Bridges & Structures 2024/25 budget to support the schemes outlined in this report (Appendix A).

The projects listed will limit the deterioration and preserve the structural integrity of the highway structures avoiding any undue failure of the structural elements.
