### Decision made

<b>Cabinet Members making the decision</b>	COUNCILLOR STEVE TUCKWELL, CABINET MEMBER FOR PLANNING, HOUSING & GROWTH
<b>Decision</b>	<b>Approved</b>  That the Cabinet Member:  1) Noted the responses received to the informal consultation for the possible extension to the West Ruislip Parking Management Scheme Zone WR2 in Bembridge Gardens, Ruislip.  2) Approved statutory consultation to be carried out on the proposed extension to the West Ruislip Parking Management Scheme Zone WR2 in Bembridge Gardens, Ruislip between the junction with Chichester Avenue and Lymington Drive, as shown on the plan annexed at Appendix D.  3) Decided that no further action is taken to progress an extension to the scheme in the section of Bembridge Gardens, Ruislip situated to the south of the junction with Lymington Drive, where the majority who responded to the informal consultation gave a preference of no change.
<b>Reason for decision</b>	The recommendations reflect the majority of responses received to the consultation with residents and views expressed by the local Ward Councillors after considering the individual responses from residents throughout the road.
<b>Alternative options considered and rejected</b>	The Council could have decided to leave the current parking arrangements unchanged or formally proposed an extension to the scheme throughout all of Bembridge Gardens.
