| Decision | Approved That the Cabinet Member for Finance & Transformation, in conjunction with the Cabinet Member for Corporate Services & Property: 1) Accepted the tender and approved the award of contract for the planned kitchen and bathroom renewals Phase 36 to PFL Electrical Ltd at a cost of £378,470.95. 2) Agreed to the capital release request of £435k inclusive of contingencies and fees from the kitchens and bathrooms renewals workstream within the housing revenue account works to stock programme 2024/25 budget for the planned kitchen and bathroom renewals phase 36. |
| Reason for decision | The proposed contract is to undertake the planned renewal of 40 kitchens and 40 bathrooms (+ 12 separate WCs) under Phase 36 of the programme, as detailed in Appendix B of the confidential report. A number of kitchens and bathrooms are in a poor condition and at the end of their useful life. |
