Decision	Approved That the Cabinet Member for Finance & Transformation and Cabinet Member for Corporate Services & Property agreed to the reallocation of previously released capital funding for the proposed development of flats at Haydon Drive, Pinner, HA5 2PN, towards the new proposals for development of 21 houses. Funds of £201k from the Haydon Drive Capital Programme Budget to be reallocated to progress the planning application for 21 houses.
