Noted the results of the informal consultation on proposed pay and display bays and a disabled bay on Uxbridge Road, Hayes; and 2. Following discussions with local Ward Councillors, asked that officers arrange for statutory consultation to take place on proposals for pay and display bays and a disabled bay on Uxbridge Road, Hayes, outside Nos. 1092 to 1120, as seen in the plan attached as Appendix C.
