Cabinet Members making the decision	Councillor Eddie Lavery – Cabinet Member for Community & Environment Councillor Martin Goddard – Cabinet Member for Finance & Transformation
Decision	Approved That the Cabinet Member for Community & Environment: 1) Approved the retention of 36 high-priority cameras identified as essential for moving traffic and road safety enforcement. 2) Agreed the proposal to replace 33 of the cameras in high priority locations to ensure continued monitoring of moving traffic regulations in these locations. 3) Agreed the decommissioning of cameras where contravention levels and receipts do not justify the continued maintenance and cost of enforcement cameras. That the Cabinet Member for Finance & Transformation, in consultation with the Cabinet Member for Community & Environment: 4) Agreed the commission of the camera replacement programme which will be by way of direct award to the

	<p>Council's current parking enforcement contractor, APCOA UK Limited for the value of £463k</p> <p>5) Approved the use of £136k revenue funds from the existing parking services budget to fund the on-going support and maintenance contracts for these cameras.</p> <p>6) Agreed to the capital release of £361k from the 2025/26 Chrysalis Programme budget for the replacement and upgrade of enforcement cameras, relocations and necessary configuration costs, as set out in the confidential report (Appendix A)</p>
Reason for decision	The recommendations ensure continued moving traffic enforcement capability across the Borough, particularly at high-risk locations such as bus lanes, weight restrictions, and banned turns. Replacing or upgrading cameras at priority sites ensures that enforcement resources remain targeted, cost-effective, and sustainable.
Alternative options considered and rejected	<p>Do Nothing - Not feasible, as cameras will cease to function when software support ends in November 2025. Not upgrading or replacing all cameras would result in traffic management and road safety risks.</p> <p>Adopt a Mixed Approach with some cameras replaced and some upgraded. Upgrading cameras will only extend their usable life for a short period, up to a maximum of 2 years, therefore requiring the replacement of the camera soon after. The total cost of this option will be significantly higher in the long-term and risks cameras being out of use for periods of time as a result of increased unreliability due to age. Therefore, this option is not recommended.</p> <p>Leasing cameras - This option has not been considered since leasing introduces a significant annual revenue requirement compared to capitalised purchase and maintenance.</p>
