<b>Decision</b>	<b>Agreed</b>  <b>The Leader of the Council, in consultation with the Cabinet Member for Residents Services:</b>  <ol style="list-style-type: none"><li><b>1. Agreed to extend the current contract for the provision of Environmental Specialist Cleaning to the London Borough of Hillingdon for One Year period from 1 April 2026 to 31 March 2027.</b></li><li><b>2. Furthermore, agreed that this included the provision to extend the contract for a further One Year period, delegating approval of the further extension to the Corporate Director of Resident Services, in consultation with the Cabinet Member for Residents Services.</b></li><li><b>3. Noted the ongoing strategic review of the services provided, including ASB fly-tip removal, clinical waste collections, and public convenience maintenance.</b></li></ol>
<b>Reason for decision</b>	In line with the Council's core vision of "putting our residents first," this contract extension ensures that high-standard cleansing and hazardous waste services remain uninterrupted.
